- BRIEF DESCRIPTION -

CiDecon Wipes are disinfectant wipes in a convenient pop-up canister. For use on hard, non-porous, inanimate surfaces, they provide broad range efficacy against bacteria, virus and fungi. Proven effective against HIV-1 and many other pathogenic organisms. CiDecon Wipes are safe, effective and meet OSHA bloodborne pathogens standard.

- DIRECTIONS FOR DISPENSING -

Remove large snap cover from container and pull up the wipe corner from the center. Twist the corner into a point and thread through the X hole on the underside of the cover. Pull the wipe completely through and replace cover onto container. Pull out first wipe at a 90° angle. Remaining wipes feed automatically. Always reseal the hinged cap after each use to ensure moisture retention.

- USE PROTOCOL -

Thoroughly wet pre-cleaned surface with wipe and allow to air dry. Blood and other bodily fluids must be thoroughly cleaned from surface and objects before application of wipes.

- ACTIVE INGREDIENTS -

Glutaraldehyde.....0.27500% o-Phenylphenol....0.01375% p-Tertiary Amylphenol....0.00275%

- EFFICACY -

When used as directed, CiDecon Wipes kill:
(10 minutes): Salmonella choleraesuis, Staphylococcus aureus, Methicillin- Resistant Staphylococcus aureus (MRSA), Pseudomonas aeruginosa, Trichophyton mentagrophyte, Human Coronavirus (HCoV).
(2 minutes): Coxsackie virus B5a, Adenovirus-2, Poliovirus 1 & 2, Rotavirus SA-11, Rhinovirus, Vaccinia virus, Cytomegalovirus, Respiratory Syncytial Virus.
(30 seconds) HIV-1 (AIDS virus), Herpes simplex virus 1 & 2, Influenza A2HK

- STORAGE AND DISPOSAL -

Store in cool area. Do not reuse wipes. Dispose of used wipe in trash after use. Do not flush. Materials that may contain blood and other body fluids should be autoclaved and disposed of according to federal, state and local regulations for infectious waste. Nonrefillable container. Do not reuse container. Offer empty container for recycling if available or discard in trash.
