Sterile Sodium hypochlorite (bleach) Solution

Technical Data Sheet

- BRIEF DESCRIPTION -

HypoSolTMST is a 5 % Sodium hypochlorite (bleach) solution for dilution and for use in manufacturing applications or as a sanitizer. Each Lot is analyzed for percent available chlorine, calcium and phosphate. Each lot is filtered to 0.2 micron, packaged in a Class 100 cleanroom and tested for sterility via a USP 14-day sterility test prior to release. A copy of lot specific documentation is attached to each case of HypoSolTMST.

-USE PROTOCOL -

HypoSolÎ ST is to be used for manufacturing applications or as a reagent. HypoSolÎ ST can be easily diluted with water to achieve the solution strength recommended for the application. If used on stainless steel, rinsing is recommended since the sodium hypochlorite is an oxidizer.

For sanitizing, HypoSolÎ ST can be easily diluted to a 10 % solution in order to result in a 0.525 % sodium hypochlorite. Apply the 10 % HypoSolÎ ST solution to the desired surface.

-EFFICACY-

A 0.525 % Sodium hypochlorite solution (10 % HypoSol ST solution) is the dilution recommended by CDC and OSHA for general disinfection and for inactivating pathogens such as HIV and HBV. The efficacy of solutions of HypoSolÎ ST for all pathogenic microorganisms is the same as any other sodium hypochlorite solutions of the same dilution.

- STORAGE AND DISPOSAL -

STORAGE. The shelf life for HypoSolÎ ST is one year from date of manufacture. Store in its original sealed container in a cool, dry area, away from heat and direct sunlight.

CONTAINER DISPOSAL. Do not reuse empty container. Dispose in accordance with federal, state and/or local regulations.

USED SOLUTION DISPOSAL. Used solution should be disposed of in accordance with federal, state and/or local regulations.

DISPOSAL OF INFECTIOUS MATERIALS. Blood and other body fluids should be autoclaved and disposed of according to local regulations for infectious waste disposal.

- PRECAUTIONARY STATEMENTS -

Harmful if swallowed or inhaled. Causes irritation to eyes and respiratory tract. Causes substantial but temporary eye injury.
